1. INTRODUCTION

Tripura JICA Project (SCATFORM)

Tripura is located in the mountainous area in the north east of India bordering Bangladesh on three sides. The state has 3.67 million people (2011) and high population increase (1.5% per year from 2001 to 2011). Industrial growth in the state is not so high compared with some of the other Indian states due to limited transportation facilities and lack of better road, rail and air connectivity with other parts of India. However, abundant forest resources (which cover 60% of the state, 2015), plentiful rainfall and fertile soil are suitable for afforestation; thus, forestry is a major source of income of the state along with agriculture. The proportion of the workforce in agriculture and forest sector as well as residents' dependence on forests is high. To monitor & maintain the assets of the Forests Internet facility is the top most priority of the department. Tripura Forest Department is already connected via SWAN project of NIC with 10 Mbps dedicated line for Forest Department. SCATFORM project which is under Forest Department has placed a Web Server for its internal monitoring which require highly dedicated lease line to meetup with the Internet requirement.

2. SCOPE OF WORK

Tripura JICA Project (SCATFORM) seeks proposals from qualified communication service providers for Internet Service Provider (ISP) to implement Internet leased line on fiber connectivity as per below mentioned specifications:

- a. Requirement of 200 Mbps Bandwidth Internet Leased Line on Fiber
- b. Bandwidth with 1:1 uplink & downlink ratio
- c. 6 No's of static IP Pools
- d. Service availability of >98%
- e. Average Network packet loss <=0.5%
- f. Provider to ensure Inclusion of active, passive components, network infrastructure for the service delivery
- g. Consistency in required bandwidth
- h. Final output shall be in the means of ethernet drop
- i. Maintenance services 24*7*365.

5. AMENDMENTS TO RFP

At any time prior to the last date for receipt of applications, TRIPURA JICA Project (SCATFORM) may for any reason, whether at its own initiative or in response to a clarification requested by a prospective applicant, modify the RFP document by an amendment. In order to provide prospective applicants reasonable time in which to take the amendment into account in preparing their proposals, TRIPURA JICA Project (SCATFORM) may at its discretion extend the last date for the receipt of proposals and/or make other changes in the requirements set out in the RFP.

6. REJECTION OF APPLICATION

The application is liable to be rejected if:

- a. Not in prescribed forms and not containing all required details.
- b. Not properly sealed and signed as per requirements.
- c. Received after the expiry of due date and time.
- d. Missing of any supporting document(s) with the Proposal.

7. DISCLAIMER

- a. The TRIPURA JICA PROJECT (SCATFORM) shall not be responsible for any late receipt of applications for any reasons whatsoever. The applications received late will not be considered and returned unopened to the applicant.
- b. The TRIPURA JICA PROJECT (SCATFORM) reserves the right
 - i. To reject any/all applications without assigning any reasons thereof.
 - ii. To relax or waive any of the conditions stipulated in this document as deemed necessary in the best interest of the TRIPURA JICA PROJECT (SCATFORM) without assigning any reasons thereof.
 - iii. To include any other item in the Scope of work at any time after consultation with applicants or otherwise

8. NO SUBLETTING ASSIGNMENT

There must be no further subcontracting without prior written consent of TRIPURA JICA PROJECT (SCATFORM).

9. MAINTENANCE OF CONFIDENTIALITY

The ISP must not divulge any confidential information and assure that reasonable steps are taken to provide for the safe custody of any and confidential information in its possession and to prevent unauthorized access thereto or use thereof. The ISP must not, without the prior written consent of TRIPURA JICA PROJECT (SCATFORM), disclose any confidential information of TRIPURA JICA PROJECT (SCATFORM) or any government department or relating to any ministry or any other party. In giving written consent to the disclosure of confidential information, TRIPURA JICA PROJECT (SCATFORM) may impose such conditions as it thinks fit, and the ISP must comply with these conditions. Confidentiality clause shall survive for a longer period of one year after the termination of contract or contract expiry period.

10. TERMINATION OF CONTRACT

a. Termination for Default

TRIPURA JICA PROJECT (SCATFORM) reserves the right to terminate / short close the contract, without prejudice to any other remedy for breach of contract, by giving one month notice if the ISP fails to perform any obligation(s) under the contract and if ISP, does not cure their failure within a period of 04 days (or such longer period as TRIPURA JICA PROJECT (SCATFORM) may authorize in writing) after receipt of the default notice from TRIPURA JICA PROJECT (SCATFORM).

b. Termination for Insolvency

TRIPURA JICA PROJECT (SCATFORM) may at any time terminate the contract by giving written notice without compensation to the ISP, if the ISP becomes bankrupt or otherwise insolvent, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to TRIPURA JICA PROJECT (SCATFORM).

c. Termination for Convenience

TRIPURA JICA PROJECT (SCATFORM) may by written notice sent to ISP, terminate the contract, in whole or part, at any time for its convenience. However, the payment shall be released to the extent to which performance of work executed as determined by ISP till the date upon which such termination becomes effective.

11. FORCE MAJEURE

Neither party shall be held responsible for non-fulfilment of their respective obligations due to the exigency of one or more of the force majeure events such as but not limited to Acts of God, war, flood, earthquakes, strike, lockouts, epidemics, riots, civil commotion etc., provided on the occurrence and cessation of any such events. The affected party thereby shall give a notice in writing to the other party within one week of such occurrence or cessation. If the force majeure conditions continue beyond six months the parties shall then mutually decide about the future course of action.

12. SETTLEMENT OF DISPUTES

All disputes and differences in relation to the RFP, the contract or the interpretation of any of there terms or implementation there or arising out of or concerned directly or indirectly with the contract shall be referred to the arbitration or a single arbitrator to be appointed by the Chief Executive officer & Project Director, Tripura SCATFROM Project and in his absence, the highest Executive officer shall make such appointment. The venue of arbitration shall be at Agartala only. The court of law at the Agartala alone will have jurisdiction in the matter of any disputes what-so-ever.
